Applicants for Jet Ski and Tender float space shall be allocated space in the order of their Club seniority. All applications for all float rentals shall be in writing, delivered to the Rear Commodore, together with payment in full of the required fees, and with a valid certificate of liability insurance, or a copy of the insurance policy. All applications and fees must be received by the adjournment of the regular March, General Membership Meeting. Applications received thereafter will be processed in the order of their receipt, by the Rear Commodore. These late applications must also be accompanied by the required fees and insurance documents prescribed above.

Primary float: An individual's float shall be considered primary if that individual has no other float space on the docks.

Secondary float: An individual's float shall be considered secondary float if that individual has another float space on the docks. Each year the Jet Ski and Tender float space will be consider open to application, the term renewal will not apply to this form of float, each year every application meeting the following guide lines shall be consider for rental. Applications for Jet Ski and Tender float space rental shall be processed in the following order.

1. New Primary Applications for float space rental received up to the March General membership meeting based on club seniority.
2. New Secondary Applications for float space rental received up to the March General membership meeting based on club seniority.
3. Applications received after the March General Membership meeting in order of receipt.
4. Applicants who missed the Fall or Spring work party but made up their requirements as outlined by the Rear Commodore. Anyone that has not made up their time requirements as outlined by the Rear Commodore will forfeit their dockage.

4. All rules and regulations pertaining to the operations and procedures for float space rental as contained in the By – Laws shall be adhered to at all times.
5. No applications can be accepted unless Proof of Liability Insurance is provided and attached to this application.

VALID COPY OF CERTIFICATE OF INSURANCE MUST ACCOMPANY THIS FORM FOR APPLICATION TO BE CONSIDERED COMPLETE. INCOMPLETE APPLICATIONS WILL BE CONSIDERED LATE AND WILL NOT BE ASSIGNED DOCKAGE.

All vessels on leased floats are to be individually insured; any violation of said policy shall hold named applicant solely liable.

I further pledge to give all assistance in the maintenance and repair of such space in the best interest of the Club, the safety of its members and guests. This application, when duly executed, shall also serve as a waiver of liability against the Bordentown Yacht Club. I understand that any misrepresentation may result in a \$100.00 fine.
